

Access Policy

Policy Statement

Our Organisation aims to provide quality Centre Based Care to children 6 weeks to 12 years.

Beresford Road, Lapstone, Pendle Hill and Toongabbie West Services provide Out of School Hours Care for Kindy to Year 6 children.

Darlington provides Out of School Hours Care for Preschool to Year 6 Children.

Toongabbie East provides care for children from 6 weeks old to Year 6 Children.

Procedures

- ✓ As per current Department of Education Child Care Provider Handbook -
 - there are no requirements for filling vacancies. Providers can set their own rules for deciding who receives a place
 - providers are asked to (but are not legally obliged to) prioritise children who are:
 - at risk of serious abuse or neglect
 - a child of a sole parent who satisfies, or parents who both satisfy, the activity test through paid employment.
 - this meets the Australian Governments aims of helping families who are most in need and supporting the safety and wellbeing of children at risk
- ✓ No one will be discriminated against on the basis of cultural background, religion, sex, disability, marital status or income.
- ✓ A Service Waiting List will be developed as necessary and updated regularly.
- ✓ Placement from the Waiting List is determined by the following
 - siblings of children already in care
 - date of placement on the Waiting List.
- ✓ Parents are able to access their status on the Waiting List on request.
- ✓ Our Organisation operates on Staff:Child Ratio as per Education and Care Service National Regulations.
- ✓ Enrolment for children with additional needs will be reviewed on a case by case basis to ensure that we have the capacity to care for the child and have staff employed with the appropriate qualifications, skills and knowledge to meet the needs of the child.
- ✓ If we do not have the capacity to care for any specific child and / or are unable to cater to their specific needs the Coordinator or Manager will try, if possible, to support the family in finding alternative care.

Children attending above Primary School Age

- Children above primary school age may only attend the Service in very special circumstances. Applications must be made in writing to the Coordinator which will then be considered by Management. Applications will be assessed on a case by case basis and subject to capacity to care for the individual child. Considerations will be made based on the family circumstances, the behaviour of the child and the impact it would have on the primary school age children in care.
- ✓ Any child above primary school age applying for a place must be known to the Service and Educators and attended care the previous year.
- ✓ Children over primary school age cannot take the place of a primary school age child.
- ✓ The Organisation reserves the right to provide one day notice for the termination of care, for any child enrolled who is above primary school age, if we need the place for a primary school age child to attend or if the behaviour of the child negatively impacts the children of primary school age.
- Considerations to allow children over primary school age will only be considered if the Service has at least 10 places free for casual users to utilise and must not impact the safety of younger children in our care.
- ✓ Our Organisation may require a child to vacate their position to allow for the Enrolment of a child/ren who fall in a higher priority of care. At least 14 days notice of the need for the child to vacate will be given.

Access Policy

<u>Preschool children attending OOSH – Darlington Activity Centre – limited to 10 places</u>

- ✓ As an OOSH service we will offer places to children attending Darlington Public School Kindergarten Yr 6 before places are offered to children enrolled in Darlington Preschool.
- ✓ Siblings of children already attending our Service will be given priority.
- ✓ Preschool children will be enrolled when they are 4 years of age and are enrolled to attend school the following year, where vacancies exist.
- ✓ Preschool children must have self help skills that allow them to be independent with: toileting, handwashing, sunscreen application, dressing, undressing, eating and drinking.
- A trial period of up to 4 weeks, which may be terminated earlier, will be required to ensure that preschool children are able to fit into the routines of the OOSH environment.
- ✓ We will accept a maximum of 10 preschool children, where vacancies exist.
- ✓ To ensure the safety, health and wellbeing of each child attending Vacation Care:
 - A child must already be attending our Before and or After School Care Service to be able to attend Vacation Care.
 - Preschool aged children will be unable to attend Excursions.
- ✓ The child must be able to follow directions from Educators on site and stay within the designated boundaries.
